NOTICE INVITING QUTATION FOR SELECTION OF TRANSACTION ADVISOR / CONSULTANT FOR SELECTION OF PARTNER FOR DEVELOPMENT, OPERATION AND MANAGEMENT OF UNIVERSAL VEGETABLE PROCESSING TRAINING CENTER FOR TOMATO POWDER AND OTHER ALLIED PRODUCTS AT DISTRICT OF JALPAIGURI, WEST BENGAL.

The District of Jalpaiguri is located at Northern part of West Bengal. The region has suitable agro-climatic zone congenial for growing conventional agri-horticultural crops inclusive of fruits & vegetables. Tomato is one of major cultivated crop in the districts of Jalpaiguri & Cooch Behar. Major quantity of the crops are getting wasted due to lack of processing industry, proper technique, packaging and marketing infrastructure. The value addition and processing of quality tomatoes and other vegetables will generate a potential market in India & Abroad and also boost up the economy of local farmers.

Keeping in view the above, Siliguri Jalpaiguri Development Authority has decided to develop a project on Universal Vegetable Processing Training Center for Tomato Powder and other allied products on 10 acre of land in Berubari, District Jalpaiguri, West Bengal. The project has been approved under ASIDE based on the DPR prepared by SJDA. The project would provide including but not limited to utility buildings, raw material store house (Cold store), ware houses (Final product store room), processing, training centre vehicle parking area, solid waste management plant, toilet & other support facilities. Total Rs 13.60 crore has been sanctioned by the government under ASIDE which will be put in the project by SJDA, phasewise, as per requirement. Besides this SJDA has already procured land and spent to the tune of Rs. 1.10 crore. Balance requirement of fund shall be met by the selected partner.

Site: On Jalpaiguri - Haldibari Road, Berubari, District Jalpaiguri, West Bengal.

SJDA proposes to develop, operate and manage the project through a private partner on Design Built Operate Transfer (DBOT) according to the Detailed Project Report (DPR) already prepared and approved by SJDA. The partner will be allowed to upgrade facilities as per requirement. The project will be allotted for 30 years period.

SJDA now invites applications from reputed experienced agencies for transaction advisory/ consultancy services for selection of partner for development, operation and management of the project.

The transaction advisor/ consultant will perform duties and provide services as per the latest Public Private Partnership (PPP) policy and guidelines of the State Govt. with upto date amendments. The TA/

consultant will also provide hand held support to SJDA in selecting Private Partner for operation and management of PDC and for installation operation & management of Waste Processing Facility


