The Sealed cover no.1 shall be superscribed as "Part-I (Technical Bid)" containing technical and financial specifications/ particulars as detailed below.

The sealed cover no.2 shall be superscribed as "Part-II (Financial Bid)" containing the rate for the work which should be quoted on quotationer's letter head.


