About the Project:

BEAUTIFICATION AND GREEN ZONE DEVELOPMENT ALONG THE ROAD FROM DARJEELING MORE TO SUKNA, DIST. DARJEELING.

Scope of Work:

The work would include preparation of details of Architectural Drawings, including preparation of details of estimate of the proposed project:

- 1) Architectural Designs including preparation of Plans, with detailed Drawings, Architectural Details etc.

- 2) Income Tax (I.T.) PAN.
- 3) Experience on successful preparation of similar type of works specifying eligibility criteria.
- 4) Valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act, 2017.
- 5) "Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017" / in terms of 4374 F (Y),

Any participant bidder not following the steps in submitting their bid /offer as described are liable to be disqualified.
