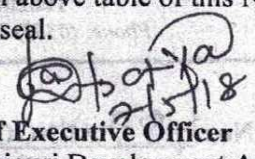

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.

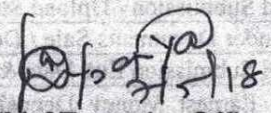
