

1. Completion of 1st year from the date of completion – **30 % of SD**
2. Completion of 2nd year from the date of completion – **30 % of SD**
3. Completion of 3rd year from the date of completion – **40 % of SD**

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.
