2. Completion of  $2^{nd}$  year from the date of completion -30 % of SD

3. Completion of 3<sup>rd</sup> year from the date of completion - 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.
