
An Expression of Interest (EOI) is hereby invited by Siliguri Jalpaiguri Development Authority (SJDA) from the registered, bonafide, reliable and resourceful Engineers / Agencies / Consultancy Firms having experience of not less than five years in Planning, Designing and preparation of DPR for Similar Project for the following area.

Scope of Work:

The work would include Detail survey, Contour, leveling, design of Drain & cross drainage structure preparation of detail estimate with bill of quantities and other ancillaries etc. The detailed estimate is to be prepared on the basis of PWD schedules. In case of non-scheduled items, analysis of rates may also be provided. The selected Consultant would have to provide the following:

- Preparation of detailed estimate, bill of quantities for the project. Vetting of estimate would be done by the Chief Engineer of Public Works Department and the fees for the same if any to be borne by the Agency / Consultancy Firm.
- Preparation of Draft Tender Documents.



ELEGIBITY TO PARTICIPATE:

Registered, bonafide, reliable and resourceful Engineers / Agencies / Consultancy Firms having not lethan five years of experience in designing similar type of project may participate in this Expression of Interest (EOI). The Multi-Disciplinary Firms / Agencies / Consultancy Firms, who have executed similar projects, may also submit their proposals. All of them should also have experience in planning and designing of at least one project of similar nature costing Rs. 3 (three) Crores or above during the last three Financial Years.

SELECTION / ACCEPTANCE OF THE SUCCESSFUL BID/ OFFER:

- a. The accepting authority/SJDA reserves right to withdraw from whole process or any part thereof or to accept or reject any or all bid(s)/offer(s) including the lowest bid/offer received at any stage of the process without assigning any reason whatsoever to the participants. No formal obligation shall accrue to SJDA or in such an event authority shall not be responsible for non-receipt of correspondence sent by post/e-mail/fax/courier.
- b. For selection/ finalization of the offer/bid, at first responsiveness will be verified as per eligibility criteria and submitted documents.

BID DOCUMENTS

Technical bid shall contain

- 1) Total Turnover of the company / firm for the last 3 years i.e. upto 31.3.2016 specifying eligibility criteria.
- 2) Partnership Deed with Registration Certificate in case of partnership firm / Trade License / Company Registration Certificate valid at least up to the date of submitting their bid.
- 3) Service Tax Registration Certificate.
- 4) Income Tax (I.T.) PAN.
- 5) Auditor's Certificate for Turnover for the last three years, i.e., upto 31.03.2015.
- 6) Registration certificate of Council of Architecture valid at least up to the date of submitting their bid
- 7) Experience on successful preparation of similar type of works specifying eligibility criteria
- 8) Key professional staff qualification and competence for the assignment (Details of Engineer and Engineers)
- 9) Concept proposal.

Any participant bidder not following the steps in submitting their bid /offer as described are liable to be disqualified.

TERMS & CONDITIONS:

- 1. Before submitting any bid offer, the intending participants should make themselves acquainted, thoroughly, with the local conditions prevailing by actual inspection of the site and take into considerations all aspects including actual size and availability of land, communication facilities, climate conditions etc. As no claim whatsoever will be entertained on these accounts, afterwards.
- All related expenditure incurred by the bidders for preparation, submission, clarification, presentation etc. shall not be borne by SJDA.
- As per the evaluation criteria specified above, selected successful bidder maybe called for negotiations for improvement of Terms of Reference and scope of work and financial terms. SJDA reserves the right to negotiate with the successful bidder.

The selected bidder will have to enter into an agreement of contract with SJDA within 10 (ten) days of issuance of the LOI.

The detailed project report would have to be submitted by the Engineers / Agency / Consultancy Firm within 2 (two) months from the date of issue of LOI.
