

deducted from each RA bill (up to 10% in total). 2% EMD is to be adjusted with the Security Deposit. The release of S.D. would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of 3 (Three) years.

1. Completion of 1st year from the date of completion – 30 % of SD
2. Completion of 2nd year from the date of completion – 30 % of SD
3. Completion of 3rd year from the date of completion – 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.


