Bid Documents Submission : The agency has to submit the quotation in a big envelop wherein two separate sealed envelopes will be there



Terms and Conditions:

1. The site of installing advertisement is 98 Nos of LED street light Poles located at the site from Basundhara Abasan More, Uttarkanya to Jorapai Bridge.
2. The agency shall not make any addition or alteration of the structures.
3. The agency should take care that no damage to the property is caused from the part of the agency or his employee and the agency shall be responsible to reimburse/ compensate for any such damage.
4. The agency shall not exhibit such Ad. Matter which are obscene in character and test and may disturb public peace and tranquillity. No matter relating to items that may cause health hazards like tobacco products or liquor etc. shall advertised.
5. The agency may be allowed to display Ad matters initially for a period of 1(one) year, it may be extended for another two years, subject to minimum increase 5% rate every year
6. Necessary GST documents as per the government rules to be furnished by the agency.
7. Payment for the next year tenure to be made before the beginning of the tenure.
8. The agency has to quote the rate for one year. Normally the highest bidder will be given the order for display right.
9. The authority has the right to accept or reject rate any of the quotation without assigning any reason thereof. The authority also reserves the right to cancel the quotation at any time.
10. The Agency may display awareness generating messages.
11. The defaulter agency in respect of any of the works of SJDA will not be allowed to participate in the bidding process.
12. The selected agency will have to sign an agreement with the authority.
13. The Agency shall maintain safety measures while installing advertisement materials to avoid any accident that may endanger public safety and the agency shall solely be liable for any such situation.
14. The Agency shall maintain that the materials in display will not disturb and put hindrance to the traffic movement.
15. The agency shall have to bear the cost of electricity bill **only in case the agency installs** glow boards/ illumination boards that consumes electricity.
16. The agreement may be cancelled any time without compensation in the event of Natural calamities, War, Govt. Direction etc. or for any such events beyond the control the Authority, or where the agencies entrusted / engaged in illegal/unlawful activity in the said location/premises.




