Engineer-in- Charge, then such testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.

The bidder shall be required to properly maintain the work including all its components for a period of 3 (Three) years from the date of completion and handing over to SJDA in proper format, a Security Deposit of 10% shall be deducted from each RA bill (up to 10% in total). 2% EMD is to be adjusted with the Security Deposit. The release of S.D. would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of 3 (Three) years.

1. Completion of 1st year from the date of completion - 30 % of SD

2. Completion of 3RD year from the date of completion - 30 % of SD

3. Completion of 3rd year from the date of completion - 40 % of SD

Failure to execute proper maintenance of the work for three years will lead to forfeiture of the security deposit.

In the event of any of the above-mentioned dates being declared as a holiday for SJDA the tender will be opened on the next working day at the appointed time.
