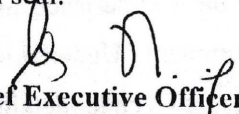

The release of S.D. would be subject to satisfactory maintenance of the work and its components for the entire period of 3 (Three) years.

In the event of any of the above-mentioned dates being declared as a holiday for SJDA the tender will be opened on the next working day at the appointed time.

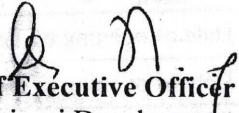
