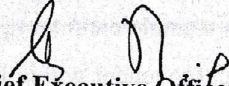

- 1 ii) 30% of the security deposit shall be refunded to the contractor on expiry of four years from the actual date of completion of the work;
- iii) The balance 70% of the security deposit shall be refunded to the contractor on expiry of five years from the actual date of completion of the work.

In the event of any of the above-mentioned dates being declared as a holiday for SJDA the tender will be opened on the next working day at the appointed time.

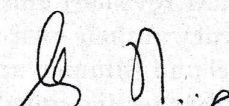
