Financial bid shall be opened/ declared only after Part-I bid (Technical) evaluation.

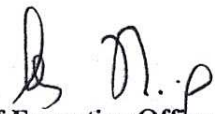

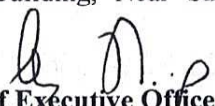
