EMD of L2 bidder is to be released only after issuance of LOI / LOA in favour of L1 within next seven working days thereafter.

If such bidder(s), having participated in the 1st tender of a work which has been cancelled due to insufficient number of participants or otherwise intends to participate in the 2nd Call of the same work, they are to submit fresh EMD and no prayer for adjustment of previous EMD will be considered.
