## General Terms and Conditions

1. The agency shall be responsible for the continuous functioning of all the electric poles, their maintenance and repairs thereof for the entire period of engagement. However, a monthly report must be sent by the Agency to SJDA about the repair works done during the month.
2. The period of engagement will be for 02 years.
3. All costs of Operation and Maintenance of Electric Poles including electricity bills shall be borne by the Agency.
4. The Agency shall be allowed the rights of Advertising on the Electric Poles.
5. The Agency shall however have to pay SJDA an amount for the Advertising Rights obtained.
6. The Rates quoted by the Agency for the above, ie amount to be paid to SJDA will have quoted in the letter pad of the agency in sealed envelopes marking clearly the Notice no and Date.
7. The interested Agencies must submit the sealed envelope in which the agency's profile must be given along with the latest IT/PT/VAT etc and clearance certificate.



8. Proof of Experience in similar nature of work of Maintenance of Electric Poles/Display of Advertisement Rights to be furnished.
9. On selection the agency must submit Rs 10,00,000 /- as security deposit, which will be kept as Performance Guarantee. Any default in payment of electricity dues by the Agency exceeding a month will compel the Authority to cancel the engagement and initiate fresh tender proceeding.
10. The Agency shall not exhibit such Advertisement matter which is obscene in character and of bad taste and which may disturb public peace and tranquillity.
11. The Agency shall not make any addition and/or alteration to the existing structure of the poles in any manner whatsoever.
12. The Agreement can be terminated by SJDA by giving a notice of one month.
13. In the event of default of payment of amount payable by the agency to SJDA, and any other dues, the same will be recoverable from the agency as public demand as envisaged under the Public Demand Recovery Act and the contract will be terminated at once without further communication.
14. No defaulter to SJDA will be allowed to participate in the Tender Process. In this regard, the decision of SJDA will be final.
15. Apart from the accepted bid, the agency will have to deposit Service Tax @ 12.36% and other taxes as applicable.
16. An Agreement will have to be entered between SJDA and the Agency.
17. The staff and workers engaged by the Agency will have to follow all security and safety rules. SJDA will not be responsible for any accident of the staff/worker(s) engaged if caused. SJDA will not provide compensation for any such accident.
18. Separate meter is to be installed for lighting at the agency's cost if required and the arrangement and the electricity charges on such meter are to be paid by the agency on due dates and time.
19. The design, size of the advertised matter, number and wattage of the lights used, the structural safety certificate from a registered engineer of the structure to be installed is to be submitted to SJDA for approval along with the location of the advertised poles.
20.
