Location of Work

1. Landscaping and beautification work of the vacant stretch along National Highway from Darjeeling More to Medical More.

Scope of Work

The scope of work would include landscaping and roadside development as given below.

- 1. Preparation of beds on both sides of the road and plantation of trees / plants / hedges accordingly. Types of trees, hedges, creepers etc., their spacing, location etc. to be decided.
- 2. Beautification may include installation of fountains of different sizes and volumes, and decorative statues.
- 3. Beautification also to include installation of sculptures of different motifs, topiaries etc.
- 4. Beautification will also include supply and plantation of grass for grass carpeting wherever required.

Bid Documents

11. Dead plants would have to be replaced during maintenance period which would be one year for all the landscaping and beautification work.

12. Routine supervision would have to be done by the consultant / agency for the entire

landscaping / beautification work from beginning to end.

13. Note SJDA will only provide the space. The plants and all other materials required for the Landscaping Work will have to be arranged by the Agency.

14. No illumination work has been included within the scope of work.
