#### **General Terms and Conditions**

- 1. The Agency shall be responsible for the repair or replace the Poles and all the related parts and its fittings, underground cable and CFL lamps, also have to keep the poles painted and straight in position with cement concrete (1:2:4), plaster (6:1) etc. so that the pole lights keep on glowing. Skilled electricians/wiremen who are having requisite certificate from the Director of Electricity will have to be engaged and must ensure about the necessary safety measures in adherence to the IE rules. SJDA will not be responsible for any accident of the staff/worker(s) engaged by the Agency, if caused and will not provide any compensation for any such accident.
- 2. All costs of Operation and Maintenance of Electric Poles including electricity bills shall be borne by the Agency.
- 3. If any light of his jurisdiction is seen not glowing for consecutive 2 (two) days, a sum of Rs. 30 for each light of each trident pole per day will be deducted from the Bill.
- 4. The Agency shall be allowed the rights of Advertising on the Electric Poles with light weight, non glowing but may be of normal or radiant type Boards.
- 5. The Agency shall however have to pay SJDA an amount to obtain the Advertising Rights.
- 6. The period of engagement will be for <u>02 years</u> but this Department has the right to terminate the contract by giving one month's notice depending on the performance of the Agency.
- 7. The Rate per year quoted by the Agency for the above, i.e. amount to be paid to SJDA will have quoted in the letter pad of the agency in sealed envelopes marking clearly the Notice no and Date.
- 8. On selection, the Agency must submit Rs. 1, 00,000 /- as Security Deposit, which will be kept as Performance Guarantee and 50% of the quoted amount per year shall be deposited within 30 days from the date of issuance of the work order, balance to be deposited within next 120 days. For the next year same payment statute will be followed.
- 9. Apart from the accepted bid, the Agency will have to deposit appropriate Service Tax and other taxes as applicable.
- 10. In the event of default of payment of amount payable by the Agency to SJDA and any other dues like electricity bills etc., the same will be recoverable from the Agency as public demand as envisaged under the Public Demand Recovery Act and the contract will be terminated at once without further communication.
- 11. No defaulter to SJDA will be allowed to participate in the Tender Process. In this regard, the decision of SJDA will be final.

12. The Agency shall not exhibit such Advertisement matter which is obscene in character and of bad taste and which may disturb public peace and tranquillity.

13. The Agency shall not make any addition and/or alteration to the existing structure of the poles in any manner whatsoever.

14. An Agreement will have to be entered between SJDA and the Agency.

15. The design, size and the advertised matter is to be submitted to SJDA for approval along with the location of the advertised Poles.
