The sealed cover no. 1 shall be superscribed as "Part - I (Technical Bid)" containing technical and financial specifications / particulars as detailed under 6 (b) and 6 (c) below along with the Earnest Money and cost of tender documents (if necessary).

The sealed cover no. 2 shall be superscribed as "Part - II (Financial Bid)" containing rate duty filled up, in the tender documents purchased or down loaded, in percentage terms At - Par, Below or Above than the Departmental Price Schedule attached for the work.

The same may be released after completion of the work with value of at least 80%
- 15. The maintenance period of the work to be considered as 3 (Three) years from the date of completion of the work and the release of Security Deposit would be subject to quality and proper maintenance of the work and its components satisfactory for the entire period of three years.
