 - The sealed cover no. 2 shall be superscribed as “Part – II (Financial Bid)” containing rate on their own letter head separately for above noted three locations.
- b) Documents to be submitted: A list of Self Attested photocopies with serial number of pages of the following documents will be submitted by the Firm / (s) in the financial part and Technical Part for pre-qualification.

 - ii) Income Tax (I.T.) PAN.
