**NOTICE INVITING QUTATION FOR SELECTION OF TRANSACTION ADVISOR / CONSULTANT
FOR SELECTION OF ORERATION AND MANAGEMENT PARTNER FOR PINEAPPLE
DEVELOPMENT CENTRE AT BIDHAN NAGAR DISTRICT DARJEELING, WEST BENGAL.**

Siliguri Jalpaiguri Development Authority in association with Food Processing Industries & Horticulture Department, Govt. of West Bengal under ASIDE scheme and funding from APEDA is developing a Pineapple Development Centre (PDC) with Post Harvest facilities at Bidhannagar, P.S. Phansidewa, Dist. Darjeeling.

Bidhannagar near Siliguri has emerged as the premier pineapple producing region and pineapple market in the country. SJDA has planned and developed a Post Harvesting facility, auction and distribution centre in 12.35 acre of land in Bidhannagar, District Darjeeling, West Bengal. The centre would provide state of the art facilities for post harvesting requirements of pineapple. There are provisions for warehousing facility, cold storage, marketing hub for traders, sorting, grading & packaging centre, online auction centre, land for processing centre, laboratory with required power, water supply, truck parking toilet & other support facilities. The facility is expected to handle about 220,000 tons of pineapple per year.

Site: Off NH 31 (East West Corridor), Bidhan Nagar, District Darjeeling, West Bengal.

SJDA proposes to operate and maintain the facility through a private partner by a suitable model. SJDA also proposes to install a Waste Processing Facility through a private partner on Built Operate Transfer according to the Detailed Project Report (DPR) already prepared and approved by SJDA. The waste management involves converting the waste generated from this facility (approximately 10% of the feed) to electricity and organic fertilizers through enhanced digestive processes. Both the operations will be allotted for 24 years period.

SJDA now invites applications from reputed experienced agencies for transaction advisory/ consultancy services for selection of partner for operation and management of the PDC.

The transaction advisor/ consultant will perform duties and provide services as per the latest Public Private Partnership (PPP) policy and guidelines of the State Govt. with upto date amendments. The TA/ consultant will also provide hand held support to SJDA in selecting Private Partner for operation and management of PDC and for installation operation & management of Waste Processing Facility


